ENVIDA'S TRANSPORTATION PROGRAM SEEKS TO EXPAND ACCESS, REMOVE TRANSPORTATION BARRIERS, AND FACILITATE COMMUNITY PARTICIPATION. IN 2018, ENVIDA PROVIDED APPROXIMATELY 24,000 RIDES THROUGHOUT EL PASO COUNTY TO MORE THAN 600 INDIVIDUALS. OUR MOST COMMON TRIP PURPOSES WERE FOR MEDICAL APPOINTMENTS (38%), ADULT DAY PROGRAMS (21%), WORK AND VOLUNTEER ACTIVITIES (19%), AND EDUCATION (18%). IN ADDITION TO PROVIDING SPECIALIZED TRANSPORTATION WITHIN COLORADO SPRINGS, IN 2018 WE LAUNCHED A PUBLIC TRANSIT ROUTE FROM CALHAN IN EASTERN EL PASO COUNTY THROUGH UNINCORPORATED PEYTON AND FALCON INTO COLORADO SPRINGS, CONNECTING WITH THE MOUNTAIN METRO TRANSIT HUB AND OUR OWN IN-TOWN TRANSIT SERVICES. THIS NEW SERVICE CONNECTS UNDERSERVED RESIDENTS IN THE COUNTY WITH THE ACCESS THEY NEED TO HEALTHCARE,
